Welcome to Hiring for Hope's "Voices of Hope" Social Network! We encourage anyone over the age of 15 to join. This network was created to provide a positive, safe, and supportive place to share your story and experiences with others. It is intended to be a place where you can feel comfortable collaborating and networking so you realize that you are not alone.

Our environment is designed to be a welcoming, open, and non-judgmental space that respects, listens, and provides support and hope to each participant. We encourage shared opinions and informative discussions between members who may have different points of view. However, please remember to be polite and respectful in your interactions with other members at all times. Your use of this network is subject to these Community Guidelines and is intended for **personal use only**. If for whatever reason you find that you are unable to abide by them, you are most likely in the wrong place.

Any solicitation of our members in any way is strictly prohibited without the prior written consent of an official Hiring for Hope company representative. Please be aware that we continually monitor all content in our community. If you are here for any of the following reasons, don't bother, your account will be immediately deactivated without a warning.

- Expressing a non-supportive view regarding any of the issues for which we provide services and support. There are numerous other organizations for this purpose. We suggest you join them instead.
- Headhunting any of our job seekers. Most of our staff is from the Human Resources and Staffing industry. We recognize this type of behavior a mile away.
- Our network is for personal use only. If we find you selling products, services, yourself, and/or hosting web graphics like banners and logos we will immediately deactivate your account. Please be aware that we are also very social media savvy and we know what solicitations masquerading as spam, "friend requests", and comments look like. Please don't waste anyone's time.

Following are a list of guidelines which were written to help us all preserve this space for its intended use. It is also our hope that they serve as a useful tool as you learn to use this wonderful free service.

Content/Tone/Privacy

Profiles, Actions, and Other Posted Materials

- You are personally responsible for any content that you publish
- All content should be submitted in English
- You control how, and to what extent, the content you contribute is shared with other members.
- Be sure to adjust your Privacy Settings to your desired comfort level upon joining.

Hiring for Hope provides a venue through which members of the public may create profiles, create actions and post other user content on the *Voices of Hope* social network. User submissions remain the intellectual property of the individual user. We have a zero tolerance policy for any inappropriate material

You are prohibited from posting or sending any unlawful, threatening, defamatory, libelous, obscene, pornographic or profane material or any material that could constitute or encourage conduct that would be considered a criminal offense or give rise to civil liability, or otherwise violate any law. Such violations may subject the sender and his or her agents to civil and criminal penalties. Copyright

- Don't steal others videos and photos and pass them off as your own. If you see a photo or video that you have created in another members profile that you have not authorized, don't panic. It's probably just a misunderstanding. Please contact them and politely ask them to remove it. If this approach is not effective, then let us know.

If you repeatedly infringe on others' intellectual property rights, we will disable your account.

<u>Safety</u>

We do our best to keep *Voices of Hope* safe, but we need your help. Please be aware of and commit to the following:

- You will not collect users' content or information, or otherwise access *Voices of Hope*, using automated means (such as harvesting bots, robots, spiders, or scrapers) without our permission.
